Subject: Preethi's Marriage to Sean Morris

Dear All,

A lot of things have happened very fast, but we saw this coming even when we first came to know about Preethi's interaction with the Church of Wells and with Sean Morris. They informed us of their decision to marry about three weeks ago and they were engaged about a week ago. They are scheduled to be married next week, Sunday, January 12th. I request your prayers, and any support or advice you can give to Preethi, or to us in the limited time we have before the date of her marriage. Preethi's email address is preethimdavid@gmail.com and her phone number is 651-399-2468. She does not usually answer her phone but she might, if she identified that it was one of you! We have expressed our unconditional love and blessings, in spite of our disagreement with her marriage and the doctrine of judgment (<http://www.thedoctrineofjudgment.com> in the way it is being practiced by the Church of Wells. We are planning to attend the marriage and have provided some financial help to Preethi with the expenses.

Attached below at the end of this email is Preethi's testimony of the same. During Preethi's time with us since we discovered her secret communication with the church of wells elders, we were grieved by her lies, deception, pursuit of an unmarried man, announcement that the church of wells elders are the new authority that she was going to submit to, rejection of saints that she grew up and their counsel, and rejection of the churches that she respected greatly in the past (she used to enjoy visiting Bethlehem Baptist Church, but she declared that "in all good conscience she cannot step into that place again"). These things caused a great amount of conflict in our house, and we physically disciplined her (once by myself when I first saw her secret letter to Sean Morris, and 5-7 times by my wife Mercy during the times she kept telling multiple lies, a smack or two each time, soap in her mouth once to say that lying lips are an abomination to the Lord) just like we did so for our children in their younger years, whenever there were moral issues to be dealt with. We had not done this for many years before this time, but the seriousness of her offences, the danger that she was subjecting herself to, and her lack of repentance drove us to these measures, which in hindsight were not wise things to do at her age. We have asked her to forgive us if any of this was done in the flesh and she has stated that she has forgiven us before she left here, and when she left home she left a very kind note to us telling us of different ways that God has blessed her through us, and she said that she was going to communicate with us every day, skype frequently and visit us every 4-6 weeks if we purchased tickets for her.

Sadly, she has shared exaggerations of our physical discipline to the Church of Wells, and any attempts to engage in meaningful conversations with them have been fruitless. Preethi's communications reduced from a daily phone call in the first couple of days, to an occasional text or phone call every 1 to 2 weeks, mainly asking for our repentance. When we ask her for clarification of what it is that we need to repent of, she says that everything we need to repent of has been clearly articulated to us. Preethi has stated that the repentance has to be towards the underlying reasons of not believing in the doctrine of judgment of Sean Morris and other doctrines of their church. They are expecting us to repent of these before the elders. Sean Morris has written threatening emails that he would expose our "physical abuse" should we slander their church to all of you. We are prepared to endure the shame and rejection that might result from their open accusations of us. Christ is our Vindicator, and God helped us to raise Preethi up in His ways by His grace alone and she was the most godly, humble, gentle, quiet, submissive, obedient child for many years since God redeemed her. We were blessed by watching her grow in the Lord. It is hard to comprehend how, within 2 weeks of secret communications with the Church of Wells elders, she was so completely deceived by their doctrine to start dishonoring the saints, practicing deceit and lies and pursuing a man of her own desires without parental

approval or the counsel of the other saints, and how she could run away from home during the early morning hours before we woke up through the backdoor.

We stand firm in faith that God's kindness will lead her to repentance. A week from now, she would be married and submitted to the authority of Sean Morris unless God intervenes in some way. We are eagerly desiring for God to intervene and deliver many from the church who been deceived into thinking that their rejection of family members is the result of the Sword of Division administered by God through them in support of God's Word.

We look forward to your prayers for Preethi and the Church of Wells members. We are committed to lift high the Name of Christ and to be clothed with Christ as we interact with the Church of Wells members next weekend as we attend the wedding. Please let us know should the Lord direct you to any Godly counsel that you might have for us. We thank God for each of you.
